Instructions for Quotation:

1. **Quoted Price:**

- (u) The tenderer shall quote for items in the format of quotation attached;
- (v) All duties, taxes and other levies payable by the tenderer (including GST on the finished service) shall be included in the item rate.
- (w) The rates quoted for each item shall be fixed for the duration of the contract and shall not be subject to any adjustment.
- (x) Rates for supply of partial quantity of an item or service are not acceptable.

2. Each tenderer must submit only one quotation

3. Bidder must submit proof of having delivered similar software / applications/ services to any Government Department / Institution of value of at least Rs 20 lakhs in the last three years

4. Bidder shall submit copy of GST Registration

5. Bidder must be a Software development firm of more than 5 year standing, registered in Karnataka and submit proof of the same.

6. **Validity of quotations:**

The quotation shall remain valid for a period not less than 30 days after the deadline fixed for submission of quotations.

7. **Evaluation of quotations:**

The Purchaser will evaluate and compare the quotations determined to be substantially responsive i.e., which are properly signed, and conform to the terms and conditions and specifications in the following manner:

- (m) The evaluation will be done including the GST. If the tenderer has not included the GST in his quotation for the item rate, and has also not indicated the rate of GST applicable, the quoted rate will treated as though it is inclusive of the GST and no extra payment for GST will be made;

- (n) The evaluation would be done for all the qualification documents first.
- (o) The qualified Tenderers shall make a technical presentation which will be evaluated and the items/ services quoted least shall be contracted. The items / services for which no rates have been quoted would be treated as zero and the total amount would be computed accordingly. The tenderer who has quoted for partial quantity of any one or more item(s)/ services would be treated as non-responsive. Purchaser will award the contract to the responsive tenderer, whose total cost for all the items put together is the lowest.

8. Award of contract:

- (u) The Purchaser will award the contract to the tenderer whose quotation has been determined to be substantially responsive and who has offered the lowest price as per para above.
- (v) The Purchaser prior to the expiration of the quotation validity period will notify the tenderer whose quotation is accepted of the award of contract. The terms of the accepted offer shall be incorporated in the Purchase order.
- (w) Normal commercial warranty/ guarantee shall be applicable to the supplied goods / services;
- (x) Payment shall be made immediately after the delivery of the goods/ services and their acceptance.
- (y) Not with standing the above, the Purchaser reserves the right to accept or reject any quotations and to cancel the quotation process and reject all quotations at any time prior to the award of the contract.
